Dividend rates on share accounts

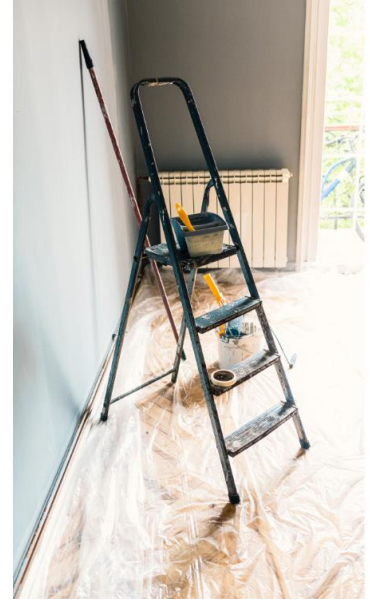
The following dividend rates and *Annual Percentage Yield for the 1st Quarter of 2022 will be paid on all share balances of \$100 or more:

| Share Bal. | *Rate/APY |
|------------------|-----------|
| \$100-\$9,999.99 | 0.20% |
| \$10,000+ | 0.35% |

Our Home Equity Line of Credit loan (up to \$50,000 at *4.00%APR) is the perfect way to borrow as you need for all those remodel jobs!



*The CFCU home equity line of credit (HELOC) has no application fee. HELOC's are available for up to 80% value of your home (less first mortgage) for a maximum of \$50,000.00 with a total repayment term of up to 12 years. The current rate of 4.00% is fixed for a period of 3 years. After 3 years, the rate is adjusted and based on Wall Street Journal Prime less 1.5%. All loans are subject to credit approval and some restrictions may apply. The CFCU is an equal housing lender.
